Rules:

1. Each vendor is responsible for his or her own sales tax permit.
2. Vendors must keep their area clean and must dispose of all trash in marked containers before they leave after setup.
3. Not responsible for thief or breakage of items.
4. Items must be clearly tagged with: assigned booth number, business Name and Price.
6. Booths must be decorated for Christmas using Santa's Wonderland Theme.
7. Electricity will be provided to vendors at no cost. Feel Free to use Christmas lights for decoration.
8. City will provide a cashier, to be on location, during all open hours.
9. The City will mail each vendor a check (including sales tax) on or before January 16, 2011. It is the sole responsibility of the vendor to report all sales tax as required by law.
10. You are required to keep your booth restocked.
11. In order to participate vendors must be setup no later than 8:00 p.m. November 30.
12. Each vendor is required to donate one item to be given away as a door prize.
13. Vendor are encouraged but not required to dress in Christmas Costumes (example: Dickens Carolers).
14. Working Vendors will be required to work 3 days or a deduction will be made to cover difference in booth prize.
15. Working Vendors will be required to work the entire floor covering the Wonderland.
